### **YOUR REQUEST FOR INFORMATION**

I am writing in respect of your request for information (ATI) dated 9 January 2017 under the provisions of the Environmental Information Regulations (EIR) (2004).

You requested NRW to provide you with:

*A documentation in relation to a plant which was built by Hudol Thermal Ltd (or Hudol Ltd) at Capital Valley Eco Park, Rhymney, Tredegar, Gwent.*

- *the dates during which the plant held an Environmental Permit;*
- *the reasons the permit was terminated*
- *any reported/observed breaches of the permit.*

The permit ZP3535MW was issued to Hudol Thermal Ltd on 23 October 2008 and a Variation Notice ZP3535MW/V002 was issued on 4 March 2013

The Permit is still extant and has not been revoked or surrendered and there has not been any breaches of permit.

The plant has not been operational since 2009.

We now consider that we have complied with your request. However, if you are dissatisfied with our response you are entitled to pursue this matter through our appeals procedure, a copy of which is below.
